The Company's fiscal year-end is December 31.

Fuseology Creative, LLC (NAICS 311941) is a Vancouver, Washington based gourmet food development company which focuses on the product development and marketing of their famous CheeseButta product line. Fueseology Creative, LLC DBA CheeseButta offers their clients a versatile and gourmet spread in a range of flavors.

Fuseology Creative, LLC began operations in September 2013. For FY21, the Company generated \$158,058 in revenue and \$22,058 of net income. During FY20 the Company generated \$68,353 in revenue and \$39,698 of net income. These financial results are historical and not representative of what investors should expect in the future.

Milestones

Michael Paul graduated from the School of Music Performance at the University of North Texas in 1995, with a major in Music Performance. Prior to founding Fuseology Creative, LLC DBA CheeseButta, Michael developed a career specializing in computer development in the restaurant point of sale industry. Michael's experience operating a family restaurant led him to create the CheeseButta line of products.

Historical Results of Operations

- Revenues and gross margin. During FY20 and FY21, the Company generated revenues of \$68,353 and \$158,058, respectively, while gross margins were 96% and 64%, respectively.
- Net income. For FY20 and FY21, the business generated earnings of \$39,698 and \$22,058, respectively.
- Assets. Total assets changed from \$30,719 at year-end FY20 to \$55,192 at year-end FY21.
- Debt. Total debt was \$43,238 at year-end FY20 and \$89,184 at year-end FY21.
